_____ **HET Retrofit:** 50% of the cost of a new Water Sense toilet replacing an existing high-flush (over 3 gallons per flush) toilet, up to \$100 per toilet.

_____ **HET Upgrade:** 25% of the cost of a new Water Sense toilet installed in new construction, up to \$50 per toilet.

Please read the guidelines below and sign indicating your agreement at the bottom:

- Rebates are available to College Station Utilities single-family residential water customers with an account in good standing.
- Rebates are offered on a first come/first serve basis and are subject to availability of funds. The rebate may be terminated at any time, without notice, by College Station Utilities.
- Submitting a Rebate Application in no way obligates the City of College Station or College Station Utilities to pay a rebate.
- College Station Utilities is not responsible for the condition of the plumbing on customer's side of the meter, now or in the future.
- Rebated toilets must be new Water-Sense labeled toilets and be installed in the City of College Station water service area.
- Rebate amounts are based on the price of the toilet **before tax**. The rebate does not cover the cost of additional parts, installation, or warranties or repairs related to removal and/or installation of toilet(s).
- A dated and itemized receipt, together with this rebate application form, must be submitted to College Station Water Services within 90 days of purchase, to: **College Station Utilities Attn: Toilet Rebate P.O. Box 9960 College Station 77842**
- Applicant is responsible for disposing of old high flush toilet(s) in a manner to prevent further reuse.
- Prior to issuance of a rebate, a representative from the City of College Station may conduct a site inspection to verify toilet installation. The toilet must be installed and functional at the time of the inspection.
- Limit one toilet per bathroom, two toilets total per account, for the lifetime of a residence.
- Qualifying products are selected based solely on water efficiency. The City of College Station does not endorse specific brands, products, or dealers; nor does it guarantee materials, workmanship, performance or durability of rebated products.
